A Resolution by the Roane County Commission establishing a moratorium, effective immediately after the adopting of this resolution and extending for one hundred and twenty days (120) days, in order to allow a review by all the regional planning commissions of Roane County of pending legislation for the changes to the location condition of site plan approvals relating to pin clinics and drug rehabilitation clinics in the Roane County,

WHEREAS, the Roane County Regional Planning Commission has not notified the Roane County Commission that there are deficiencies in the current Roane County Zoning and,

WHEREAS, these deficiencies may allow developments to occur that will incur to the taxpayers of Roane County, Tennessee extensive costs for reviewing, monitoring and policing certain land uses such as pain clinics and drug rehabilitation clinics which deal in drug dependencies which include but are not limited to heroin, methadone, pain killers, or service individuals with chronic or other pain related issues; and

WHEREAS, it is in the best interest of Roane County that it will exercise this permissive authority, and

WHEREAS, the Roane County Regional Planning Commission has specific proposals that will address and correct these deficiencies in the current zoning resolution pertaining to the location and conditions of site plan approvals relating to pain clinics and drug rehabilitation clinics;

THEREFORE, BE IT RESOLVED; by the Roane County Commission that there shall be a moratorium, effective immediately after the adoption of this resolution and extending for one hundred and twenty days (120) days, in order to allow a review by all the regional planning commissions of Roane County of the pending legislation for the changes to the location and condition of site plan approvals relating to pain clinics and drug rehabilitation clinics in the Roane County zoning resolution.
