HEARING OF DELEGATION:

John Dennis addressed the Commission to express appreciation for all who offer their services to the county including, but not limited to, the Roane County Commissioners, a special mention of Reverend Mike Hooks who led prayer. Mr. Dennis also discussed his hope for the new leaders of the nation and respect for the old ones. In closing, Mr. Dennis gave a brief history of the Federal Reserve dating back to 1913 and how it has affected the gold standard of U.S. currency citing the previous power invested in Congress to coin money.

Julian Ahler addressed the Commission to request that there be no easement or proposal of easement on Stage Road, also known as "Old Gordon Road" and stands with the Black Creek community in litigation that aims to keep it open for use and maintenance. The road was named for a Mr. Gordon, built around 1820, and still has uses, including sole access to a cemetery in the area according to the speaker . Mr. Ahler hopes for no easement of that road until the litigation is complete.

COUNTY ATTORNEY'S REPORT:

Attorney Greg Leffew discussed two particular cases involving the county, one of which was ruled in favor of and one against. The case that was ruled against Roane County has been appealed and is waiting to be heard in the court of appeals involving a Mr. Zumstein who sued the county for some \$12,325.00 to cover the attorney fees that he accrued during the process of appealing his property tax assessment. The other case involved the questioning of 26 property assessments for the year 2010 in the name of Farnham and was dismissed by the Knox County Chancellor. No appeals have been filed by the plaintiff as it stands.

COUNTY EXECUTIVE'S REPORT:

November 14, 2016 Update to the Commission

Below please find an update on happenings in Roane County related to county government operations. Also please continue to read the monthly newsletter as we put a host of information regarding county government in our publication. The newsletter is available on the website.

I'm will not be attending the commission meeting as I will be travelling to an intergovernmental meeting out of state. The meeting in related to the Energy Community Alliance (DOE related).

Industrial Economic Development/Tourism

With the Happy Valley site being sold, the county and city of Oak Ridge along with our residents and guests have lost access to the K-25 Overlook facility. We are working with the new property owner to be able to use the Overlook for a period of time as Roane County and the City of Oak Ridge work with the National Park Service to set up the Manhattan Project National Historical Park. We will try to have a resolution for our December commission meeting.

Resolutions for November

#11-16-11- is a resolution that requests the Chancellor to rescind our bids on certain Back Tax Properties. The committee did not have a quorum so no recommendations were able to be made. As County Executive, to help protect Roane County finances, I recommend adoption with an amendment of switching the attachment of 61 properties to 40 properties.

Future Resolutions for November/December timeframe

Purchase of the Dollar General Store- The county's interest in the Third Street Dollar General Store has been expressed for a number of years. The county has requested the owner to make an offer on the property for a couple of years. Recently, the owner expressed a desire to sell. We have requested the owner to submit his offer in writing. Committees of Budget, Property, Jail Study Committee, and Sheriff Liaison should discuss at their next meetings.

This acquisition has been noted in the county's capital outlay plan and in a Jail Plan that has been submitted to the state in conjunction with the Tennessee Correctional Institute (TCI) jail inspections. We anticipate a resolution in December to establish a capital project account **we do not anticipate** having to borrow monies for this acquisition.

Swan Pond Sports Complex Paving Discussion

The county's sports and recreation committee met as noted in the **correspondence #11.** At the meeting there was discussion of paving the road and parking lot at the complex. We will receive estimates as requested but do not feel that we should pursue the road at this time as TVA continues to work at the far northern end of the property and often has heavy equipment travelling the road. We think it is in our best interest to wait and insure as best as we can that the road would not have heavy equipment travelling and damaging the road. Further, since there is also further construction plans at the site we would recommend that the county complete most of our heavy construction work prior to completing the road. Like building a house the last work is the road work due to potential damage of concrete trucks, block and brick truck, etc. We should exercise these "best practices".

WHEREAS, on September 24, 2016, the Clerk and Master held a delinquent tax sale for delinquent Roane County taxes for the 2012 tax year as ordered in Case Number 2014-41, Roane County, Tennessee v. Delinquent Taxpayers for the 2012 Real Property and 2012 Personal Property for Roane County, Tennessee.

WHEREAS, Roane County was required to enter bids on certain properties sold at said sale, and became the owner thereof.

WHEREAS, Tennessee Code Annotated Section 67-5-2507(c) provides to the County Executive a period of no less than ninety (90) days and no more than one hundred twenty (120) days to evaluate said properties and determine whether the value of each property or the amount of money the County is likely to receive upon the sale of the property exceeds the financial or environmental risks associated with the property.

WHEREAS, said statute allows County Commission, by twothirds vote, to adopt a resolution directing the County Executive to petition the Chancellor for relief from the tax sale regarding any properties where the financial or environmental risks of the property outweigh the value of the property or the amount of money the County would likely receive if the County sold the property.

WHEREAS, the County Executive has evaluated all of the properties Roane County was required to purchase at said tax sale and determined which properties pose financial or environmental risks that outweigh the value of the property or the amount of money the County is likely to receive if the County sold the property. Said properties posing such financial or environmental risks are listed on the attached spreadsheet.

WHEREAS, the County Commission finds that it is not in the best interest of Roane County to acquire such properties because the financial or environmental risks posed exceed the values of the properties or the amount the County would receive upon the sale of the properties.

NOW, THEREFORE, BE IT RESOLVED that in accordance with Tennessee Code Annotated Section 67-5-2507(c), the County Executive is hereby authorized and empowered to petition the Chancellor for relief from the 2012 tax sale regarding the properties set forth on the attached spreadsheet, and the County Attorney is authorized and empowered to file all petitions and prosecute all actions necessary to obtain court orders relieving Roane County from its bids on the aforesaid properties described on the attached spreadsheet.
